<b>IF THIS HAPPENS</b>				<b>DO THIS</b>			
<b>Vehicle accident</b>				Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>			
<b>Spill or leak</b>				Wear suitable protective clothing. Restrict access to contaminated area. Contain the spill and prevent further dispersion. Retrieve intact containers from site. Place damaged containers into containment devices. Absorb spills with inert material and place in waste containers. Wash the area with water and absorb with further inert material. Collect spilled material and place in sealable containers for subsequent disposal. Prevent contamination of water courses or sewers. Dispose of waste safely.			
<b>Fire</b>				<b>Call the Fire Service: Dial 111.</b> Extinguish using water spray or chemical foam. Combustible liquid. Do not allow water to enter drains. For fire-fighting wear breathing apparatus (smoke containing decomposition products may be a hazard to health).			
<b>FIRST AID</b>							
<b>If swallowed</b>				If swallowed, seek medical attention. Do NOT induce vomiting.			
<b>If in eyes</b>				If splashed in eyes, wash out immediately with water.			
<b>If on skin</b>				If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water.			
<b>If inhaled</b>				Remove patient to fresh air.

Storage: Store below 30 °C. Protect from light. Keep out of reach of children.
