<b>Data and interpretation:</b>	May be harmful if swallowed. Repeated exposure may cause skin allergy. Danger of serious damage to health by prolonged exposure if swallowed. May affect development and/or reproduction. May have effects on or via lactation.
<b>Summaries data:</b>	<u>Abamectin:</u> Abamectin is an acute oral toxin [LD <sub>50</sub> (oral) 8.7-12.8 mg/kg]. Ingestion of a single large dose of abamectin by humans (~ 100 mg/kg) was associated with coma, hypotension and respiratory failure. Clinical signs in repeated-dose laboratory animal studies included ataxia, tremor, mydriasis, emesis, pupil dilation and coma. High doses produced respiratory failure and deaths. The critical adverse effects in multigenerational reproductive studies were mortality and reduced weight gain of pups in early lactation (NOAEL 0.12 mg/kg/d). <u>Benzenemethanol:</u> An organic alcohol that is used as a preservative [LD <sub>50</sub> (oral, rabbit) 1050 mg/kg; LD <sub>50</sub> (dermal, rabbit) 2000 mg/kg]. It is a known skin sensitiser (contact dermatitis) and a moderate eye irritant. <u>Copper versenate:</u> Low to moderate acute toxicity. Copper may induce allergic contact dermatitis in susceptible individuals and is eye and skin irritant. Repeated dose chronic studies reported reduced growth rates, liver and kidney effects and microcytic anaemic in laboratory species. <u>Iodine EDDI:</u> An acute oral toxin (doses of 2-3g iodine have been fatal). Iodine salts are eye, skin and mucous membrane irritants.

	<p>Skin sensitiser. Chronic ingestion of large amounts of iodine (200 mg/day) results in thyroid disease.</p> <p><u>Selenium</u>: Sodium selenate is acutely toxic [LD<sub>50</sub> (oral) 25mg/kg]. Dusts are toxic if inhaled and irritant to eyes. Acute poisoning exhibits as dyspnea, spasms and death from respiratory failure. Selenium poisoning in humans has been described and gastrointestinal and neurological symptoms predominated. Potential mutagen. Repeated dose testing in laboratory species identified a lowest NOAEL of 0.37mg/kg/day (liver toxicity).</p>

<b>Potential environmental interactions:</b>	Very toxic to aquatic organisms. Harmful to the soil environment. Very toxic to terrestrial invertebrates.
<b>Data organisation :</b>	<p><u>Abamectin</u>: Abamectin is a highly effective insecticide and acaricide produced by the soil microbe <i>Streptomyces avermitilis</i>. It acts by stimulating the release of gamma-aminobutyric acid, an inhibitory neurotransmitter, causing paralysis of the parasite. It is highly toxic to invertebrates in the aquatic, soil and terrestrial environments. Aquatic organisms: Abamectin is highly toxic to fish and extremely toxic to aquatic invertebrates [LC<sub>50</sub> Rainbow trout is 3.6 ppb (96hrs); EC<sub>50</sub> <i>Daphnia magna</i> 0.34 ppb (48hrs) ]. Persist: yes. Soil organisms: Dung beetle Terrestrial fate value 20-40. Abamectin is toxic to mammals [LD<sub>50</sub> (oral, rats) 8.7 mg/kg], but is less toxic to birds [LC<sub>50</sub> Bobwhite quail &gt;2000 mg/kg]. Abamectin is highly toxic to bees [LD<sub>50</sub> (oral) 0.0094 µg/bee; LD<sub>50</sub> (contact) 0.002 µg/bee].</p> <p><u>Benzenemethanol</u>: An organic alcohol that is used as a preservative. Benzenemethanol is toxic to aquatic and soil organisms [LC<sub>50</sub> <i>Lepomis macrochirus</i> 10mg/mL (96hrs); EC<sub>50</sub> <i>Daphnia magna</i> 55 mg/L (24hrs); EC<sub>50</sub> microbial 50 mg/L] and is a potential terrestrial vertebrate toxin based on laboratory animal toxicity data [LD<sub>50</sub> (oral, rabbit) 1050 mg/kg].</p> <p><u>Copper versenate</u>: Toxic to aquatic species (no data, 9.1D).</p> <p><u>Iodine EDDI</u>: Very toxic to aquatic organisms [LC<sub>50</sub> (96hr, Rainbow trout) 530 µg/L; EC<sub>50</sub> (48hr, <i>Daphnia magna</i>) 160 µg/L]. Toxic to terrestrial vertebrates based on an acute oral LD<sub>50</sub> (rat) of 960 mg/kg. Potentially a terrestrial vertebrate toxin based on acute toxicity data.</p> <p><u>Selenium</u>: Very toxic to fish [LC<sub>50</sub> (96hr, Flathead minnow) 690 µg/L], to crustacea [LC<sub>50</sub> (48hr, <i>Grammarus pseudolimnaeus</i>) 83 µg/L] and algae [EC<sub>50</sub> (96hr, green algae) 0.2 mg/L]. Toxic to plants [EC20 (22d) 0.1 mg/kg soil]. Toxic to terrestrial vertebrates based on an acute oral LD<sub>50</sub>(rats) of 25 mg/kg. Selenium is bioaccumulative and persists.</p>
